PARTICIPANT UNDERSTANDS THAT ApHC STRONGLY ENCOURAGES THE USE OF ASTM/SEI APPROVED PROTECTIVE HEAD GEAR IN ALL ApHC GAME CLASSES AND THAT WEARING PROTECTIVE HEAD GEAR CAN PREVENT SERIOUS INJURY OR DEATH.

In consideration of being permitted to participate in game classes at Appaloosa Horse Club ("ApHC") approved and /or sponsored horse shows or events, Participant, for himself or herself, and for his or her legal representatives, heirs, distributes and assigns (collectively "Releasers"), hereby releases, waives and discharges the ApHC, its affiliated organizations, including, but not limited to, show management, sponsors, promoters and advertisers and the owners and leases of any premises upon which any ApHC approved show or event is held; and each of them, their directors, officers, employees, agents, contractors and members (collectively "Releases") of and from any and all liability, action, claim, demand, expense, loss or damage of whatever kind or nature to Participant and Releasers arising from personal injuries, death or property damage to Participant or others arising directly or indirectly from or attributable in any way to Participant's participation in a game class at any ApHC approved and/or sponsored horse show or event whether caused by the negligence, action or omission of Releasees or any other cause; and hold harmless, indemnify and agree to defend ApHC and Releasees from any and all claims arising from Participant's participation in any such game class.
